



Parking is available at a number of locations within Guernsey Harbours' Estate; designated as follows:

Port Permit

Marine Trader

Guernsey Boatowners Association

Fishermen

The relevant Permit must be obtained from either Guernsey Harbours or the Guernsey Boatowners Association. However the following criteria will apply:

- **Port Parking**

Available to Guernsey Harbours' tenants or those that work on Guernsey Harbours' estate. Permits are chargeable and available in a variety of calendar periods:

Annual Permit		£612
Six Monthly Permit		£357
Monthly		£65
Daily/Temporary Permit		£10

An invoice will be raised once the Permit has been issued.

Permits are issued with the understanding that these are an enabler to working at the port. They are valid for use by the named driver whilst on business at the port and abuse of this may result in the permit being rescinded.

Parking is only permissible in the marked '**Port Parking Permit**' bays. Use of Port Parking Permits in any other designated parking areas will result in Fixed Penalty tickets being issued.

- **Marine Trader**

Available to marine traders whose **CORE** business (at least 50% of their business) is associated with boats relating to:

- attending or working on a boat in a marina or on Guernsey Harbours' land
- undertaking short sea trials or movement of boats (maximum period: 6 hours)
- collection/delivery of goods associated with marine trade

All contractors working on Harbour premises are required to have the appropriate insurance cover (**Third Party Public Liability** with a minimum cover of £2 million), a copy of which must accompany the application for a Marine Trader Permit. Alternatively, confirmation from insurers can be e-mailed to [guernsey.harbour@gov.gg](mailto:guernsey.harbour@gov.gg).\* **Permits will not be issued until such certification/insurer's verification has been received.**

*\*If insurance cover expires prior to the Permit expiry date, please ensure a copy of the renewed certificate is forwarded to Guernsey Harbours. Alternatively, your insurers may confirm via e-mail that cover has been maintained.*

Guernsey Harbours has introduced a charge of £25 per Marine Trader Permit issued to cover administrative and policing costs for 2016 going forward. Permits can be registered to more than one vehicle (maximum number: 4); the Permit should be switched between vehicles as required. An invoice will be raised once the Permit has been issued.

Permits are limited; therefore those marine traders requiring ad hoc access should obtain a Daily Permit from Guernsey Harbours as and when required. The charge is £10 per day. The insurance criteria remain the same as for an annual Permit and proof of the relevant insurance cover should be produced upon each application. Parking is only permissible in the marked '**Marine Trader**' bays. Use of Marine Trader Permits to park in any other designated parking areas will result in Fixed Penalty tickets being issued.

- **Guernsey Boatowners Association**

Available to Guernsey Boatowners Association (GBA) Members only. These Permits are managed by the Secretary, GBA, who should be contacted directly.

Parking is only permissible in the marked '**GBA**' bays. Use of GBA Permits to park in any other designated parking areas will result in Fixed Penalty tickets being issued.

- **Fishermen**

Available to Fishermen only for use on the Fish Quay.

Permits are only valid whilst the driver of the vehicle is 'on duty' at the harbour or 'at sea'. They are not valid for shopping excursions into Town or when used by a person other than the named driver, eg a member of the driver's family. Permits can be registered to more than one vehicle (maximum number: 2); the Permit should be switched between vehicles as required.

Vehicles parked in a Fish Quay area and not displaying a permit will be issued with a Fixed Penalty ticket.

Parking is only permissible in the marked '**Fishermen/Fish Quay**' bays. Use of Fish Quay Permits to park in any other designated parking areas will result in Fixed Penalty tickets being issued.

## **General**

A limited number of Port Parking Permits are available to purchase at market rates by those who are not Guernsey Harbour tenants and do not work on Guernsey Harbours' Estate. Interested persons should contact [guernsey.harbour@gov.gg](mailto:guernsey.harbour@gov.gg) or telephone 720229.

**Reported abuse of Port Parking/Marine Trader/Fish Quay Permits will result in the Permit being rescinded and a fee charged for re-issue.**
