Repairs to the wave attenuation pontoons at St Sampson's Marina were also completed as one of the steel piles failed in easterly gales. On behalf of us all at Guernsey Harbours, I would like to personally thank all of you for your co-operation in allowing us to carry-out this work.

Looking forward to the season, we are excited to be welcoming a number of rallies as well as supporting a number of nautical events, which will show Guernsey in all its nautical splendor. I do hope you will enjoy and embrace these events.

### **Pontoons**

Pontoons must be kept clear of crabpots, hosepipes, ropes and dinghies etc. Any items found will be removed and kept at the Marina Office for collection by the owners.

# **Electricity**

If you require electricity at your marina berth, please give us 48 hours-notice to set this up. Application forms are available on www.harbours.gg or from Guernsey Harbours office. This is currently charged at £40.00 per calendar year but is under review. Should you have any issues with your electricity connection, please call our Marina Attendants in the first instance on 725987.

#### Insurance

All vessels moored in our marinas/harbour areas are required under legislation to have current third party liability insurance for a minimum value of £1,000,000.00. Although we no longer require a copy of your insurance certificate we may request sight of it at any time.

#### **Facilities**

The toilets and showers on the Albert Pier, Crown Pier and East Arm remain available for all local mooring holders. The access codes for these buildings are changed regularly, should you wish to use the facilities please call the Marina Office on 725987 to obtain the up to date code.

### Local Notices to Mariners (LNTMs)

We recommend that boat owners regularly check www.harbours.gg/Guernsey-Navigation-Warnings-Notices as this is where we disseminate important navigational information, otherwise known as Local Notices to Mariners (LNTMs). These warnings will also be sent out via the Guernsey Harbours Twitter and Facebook pages.

### **Mooring Waiting List**

Following an extended period of contacting all those registered on the Mooring Waiting List, we have decided that the waiting list will be closed down. We have a surplus of available moorings and despite offering moorings to all those on the list – there has been no real uptake. We will continue to monitor the situation and, should we find ourselves in the position where demand exceeds capacity, we will consider an appropriate system. Please spread the word that the marinas are open for business and we welcome new enquiries.



## **Marina Office Hours**

Marina Attendants will be available between 0600 – 2200 except on Christmas Day, Boxing Day and New Year's Day. Port Control will continue to be manned 24/7. This is in order to provide more focused customer service to local and visiting boat owners during the peak hours.
