Subject	COVID 19 - Leisure Vessels - Country and
	Regional Categories for Travel

The Guernsey Civil Contingencies Authority has agreed to reintroduce country and regional categorisation for travellers to the Bailiwick of Guernsey from 23 April 2021.

Visiting Vessels

If you intend to visit the Bailiwick of Guernsey and you have travelled from or through a **Category 4** country or region I the last 14 days you must:

- Register on the Travel Tracker and enter your journey within 2 days prior to arrival
- Initially proceed to St Peter Port harbour for clearance, if your destination is in Guernsey, Herm or Sark; or proceed to Braye Harbour if your destination is in Alderney.
- Self-isolate on board or at a declared address ashore for 21 days, or agree to take a Covid test on arrival and at day 13, with release from isolation following a negative Day 13 test.

Captain David Barker Harbour Master From 23rd April, if you have travelled from or through a **Category 3** country or region in the last 14 days, you must:

- Register on the Travel Tracker and enter your journey within 2 days prior to arrival
- Initially proceed to St Peter Port harbour for clearance, if your destination is in Guernsey, Herm or Sark; or proceed to Braye Harbour if your destination is in Alderney.
- Self-isolate on board or at a declared address ashore for 21 days, or agree to take a Covid test on arrival and at day 7. Once a negative test result is obtained, continue in passive follow-up until day 14.
- If travelling with family members or friends, you must continue to selfisolate until EVERYONE in the party receives a negative day 7 test.

If you arrive outside working hours, you should proceed to an isolation pontoon (as directed by Guernsey VTS – VHF Ch.12) and await the attendance of Harbour and/or Border Agency personnel the following morning.

Bailiwick of Guernsey Vessels Intending to Visit Other Jurisdictions

If you leave the Bailiwick and visit another port in a **Category 4** country or region you must:

- Register on the Travel Tracker and enter your journey within 2 days prior to arrival
- Initially proceed to St Peter Port harbour for clearance, if your destination is in Guernsey, Herm or Sark; or proceed to Braye Harbour if your destination is in Alderney.
- Self-isolate on board or at a declared address ashore for 21 days, or agree to take a Covid test on arrival and at day 13, with release from isolation following a negative Day 13 test.

Captain David Barker Harbour Master From 23rd April, if your destination is in a **Category 3** country or region, you must:

- Register on the Travel Tracker and enter your journey within 2 days prior to arrival
- Initially proceed to St Peter Port harbour for clearance, if your destination is in Guernsey, Herm or Sark; or proceed to Braye Harbour if your destination is in Alderney.
- Self-isolate on board or at a declared address ashore for 21 days, or agree to take a Covid test on arrival and at day 7. Once a negative test result is obtained, continue in passive follow-up until day 14.
- If travelling with family members or friends, you must continue to selfisolate until EVERYONE in the party receives a negative day 7 test.

If you arrive outside working hours, you should proceed to an isolation pontoon (as directed by Guernsey VTS – VHF Ch.12), or to your permanent mooring, and await the attendance of Harbour and/or Border Agency personnel the following morning.

In all cases, if you intend to isolate at a nominated address, you should travel directly from your mooring to that address by your own vehicle or a taxi (not using public transport), keeping the windows open, using hand-sanitiser, wearing a face covering and maintaining as much social distance from the driver as possible and 2 metres from all other personnel.
