| Subject | COVID 19 – 22 October 2021 - Visiting Leisure |
| | Vessels |

As of **22 October 2021** the following applies to **Visiting Leisure Vessels from outside** of the Bailiwick:

- All arrivals who have been only in the Common Travel Area (CTA) in the previous 10
 days to use the 'blue' channel, regardless of vaccination status, meaning no testing
 or self-isolation requirement.
- The Bailiwick of Guernsey has adopted the UKs red list and will no longer classify Countries and Regional Classification as Categories 1 - 4.
- The Bailiwick of Guernsey accepts valid vaccination certification of an approved vaccine (AstraZeneca, Pfizer, Moderna and Jannsen) from all international jurisdictions.
- Children will not be required to take a PCR test before returning to education after travel. <u>Read more.</u>
- From Friday 22 October, 2D bar codes are expected to be available for Bailiwick of Guernsey residents as part of their digital vaccination certification.
- From Wednesday 27 October, fully vaccinated passengers arriving from outside the
 common travel area, from countries NOT on the UK red list will no longer be asked to
 do a PCR test. Instead they will be required to purchase a pack of 5 LFTs, they must
 take the first test on their day of arrival, and then use the rest over the following
 days. They do not need to isolate.

CTA - Common Travel Area: United Kingdom, the Bailiwick of Guernsey, the Bailiwick of Jersey, the Isle of Man and the Republic of Ireland.

Fully vaccinated – Traveller can provide the necessary proof they have received a full course of an approved vaccine (AstraZeneca, Pfizer, Moderna and Jannsen) and 14 days have passed since their last dose.

Travel within the Common Travel Area (CTA) - Blue Channel

All travel from the CTA regardless of vaccination status will be treated as 'blue'. This means:

• No isolation or testing requirements on arrival.

Travel from outside of the Common Travel Area (CTA) All travel from outside of the CTA within the last 10 days will be required to:

For vaccinated travellers - from rest of the world

- Day 1 PCR test for travellers aged 12 and over.
- No isolation.
- Children aged 11 and under will not be tested and will follow the same self-isolation requirements as accompanying parents/guardians. Children under the age of 11 must be registered on the Travel Tracker account of one travelling adult only.
- Unvaccinated children aged 12-17 will be tested and follow the same self-isolation requirements as accompanying parents/guardians. If the parents are vaccinated the parents vaccine details can be added to the child's travel tracker account, so they can benefit from this vaccinated status.
- 12 17 year olds with one dose of vaccine plus 14 days since dose are considered fully vaccinated.
- If you decline to take a test, you must self-isolate for 10 days.

For unvaccinated travellers - from rest of the world

- Day 1 and Day 8 tests for travellers aged 12 and over.
- Isolate until Day 8 negative result.
- Children aged 11 and under will not be tested and will follow the same self-isolation requirements as accompanying parents/guardians. Children under the age of 11 must be registered on the Travel Tracker account of one travelling adult only.
- Unvaccinated children aged 12-17 will be tested and follow the same self-isolation requirements as accompanying parents/guardians. If the parents are vaccinated the parents vaccine details can be added to the child's travel tracker account, so they can benefit from this vaccinated status.
- 12 17 year olds with one dose of vaccine plus 14 days since dose are considered fully vaccinated.
- If you decline to take a test, you must self-isolate for 10 days.



For all travellers, vaccinated and unvaccinated, travelling directly into the Bailiwick from a region on the UKs red list

- Day 1 and Day 9 PCR tests for travellers aged 12 and over.
- Isolate until Day 9 negative result.
- Children aged 11 and under will not be tested and will follow the same self-isolation requirements as accompanying parents/guardians. Children under the age of 11 must be registered on the Travel Tracker account of one travelling adult only.
- Unvaccinated children aged 12-17 will be tested and follow the same self-isolation requirements as accompanying parents/guardians. If the parents are vaccinated the parents vaccine details can be added to the child's travel tracker account, so they can benefit from this vaccinated status.
- 12 17 year olds with one dose of vaccine plus 14 days since dose are considered fully vaccinated.
- If you decline to take a test, you must self-isolate for 10 days.

For all travellers, vaccinated and unvaccinated, travelling from a region on the UKs red list via the UK into the Bailiwick

- You cannot transit through the UK. You must complete self-isolation requirements in the UK.
- Once completed, you can travel as a Blue Channel traveller. (See Blue Channel above).

Visiting Vessels Procedure

If you are visiting the Bailiwick of Guernsey you must:

 Register on the Travel Tracker and enter your journey within 8 days prior to arrival in the Bailiwick. <u>Welcome to the Travel Tracker | Guernsey Travel Tracker (gov.gg)</u>
 Using the address:

- Additionally, If your destination is Alderney, complete a 'Recreational Vessel Booking form' available here: <u>CHttpHandler.ashx (gov.gg)</u> at least 48 hrs before arriving in Braye harbour.
- Initially proceed to St Peter Port harbour for clearance (Calling Victoria Marina VHF Ch.80) if your destination is in Guernsey, Herm or Sark; or proceed to Braye Harbour if your destination is in Alderney.
- You will be directed to a suitable berth where <u>you must wait onboard</u> until your Travel Tracker App is inspected and you are advised of any testing or isolation requirements to allow your entry into the Bailiwick.
